










Summary of Minutes of Monitoring of Code of Conduct Committee 2016-17

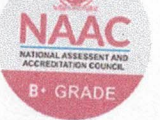
During the academic session 2016-17 different types of co-curricular/extra-curricular activities and meetings were organized by the committee. The committee mainly organize meeting as follows:-




Summary of Minutes of Monitoring of Code of Conduct Committee 2017-18

- Guest Lecture on Topic *Importance of Code of Conduct* by Dr. Abhinesh Surana, Professor in Hindi Government V.Y.T. PG. College (24/09/18)
- Guest Lecture by Dr. Sanjay Das, Department of Geography on 24/09/18 of Government V.Y.T. PG. Autonomous College, durg, was organized on topic Modulation of student's behavior through code of conduct.
- Meeting held before Conduction of Student Union Nomination was held on 24/09/18.
- Meeting held before Annual Gathering (28/01/19)

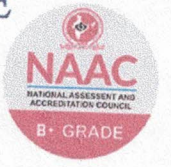

Summary of Minutes of Monitoring of Code of Conduct Committee 2019-20


During the academic session 2019-20, the committee mainly organized meetings as follows:-

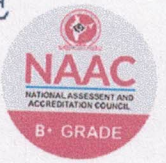
