8. (i) Project Title: "Morpho-Taxonomic studies of Flora of Indira Gandhi Government College Vaishali Nagar Campus with proper Tagging"

(ii) Introduction:

Assessment in view of the need for conservation of environmental quality. It is essential to develop familiarity with the vegetation around, in order to develop a sense of responsibility towards their conservation. Indira Gandhi Government Arts and Commerce College, Vaishali Nagar has a vast area, where a rich flora can be observed. This richness of flora is not only responsible for the healthy ecosystem maintained in the college, but also gives students an understanding of the causes and benefits of healthy ecosystem. And this in turn inculcates a feeling of concern for its conservation. The purpose of this project proposal is to prepare a digital flora for the benefit of the students who have to prepare a field report of the flora study of an area and in turn acquaint them with the richness of flora around them. - g) The digital database thus preparedwould also be uploaded on the college website.
