



Qualitative analysis of Criterion 1

The college is affiliated to the Hemchand University, Durg and is governed as per rules and regulations laid down by dept. of Higher Education, Chhattisgarh Govt. It adheres to the curriculum designed and prescribed by the University and the same is communicated to the students. The proper implementation of the curriculum is ensured through periodical faculty meeting of the departments concerned by discussing the syllabi status and other academic activities. The departments also ensure sufficient availability of learning resources such as text books, braille books, thesis gallery, e-books and laboratory facilities. The induction program for the fresher need to be conducted by the Principal with the help of the faculty members.

The college follows annual academic calendar for UG and semester pattern for PG as notified by the affiliating University and State Govt.'s Higher Education dept. for internal evaluation i.e. continuous internal evaluation (CIE). The teachers demonstrate adequate teaching skills through field visits/ project work/ presentation/ assessment. It also conducts half yearly exams/ practical exams for UG class and semester end exams/assessment/practical exams for PG class as per notified academic calendar.

The college has limitations to integrate cross cutting issues like Gender, Human Values, Environment and Sustainability and Professional ethics in the curriculum. Issues related to professional ethics, gender, human values, environment and sustainability are part of curriculum of the subject like Botany, Zoology, Chemistry, Geography, English, Environment, Industrial micro-biology. Human value is also part of syllabi in social sciences and languages. The college needs to develop proper mechanism to measure the achievement of objectives of the curriculum. Online feedback obtained from all stakeholders need systematic analysis for effective implementation.

Qualitative analysis of Criterion 2

The college assesses the learning level of its students based on learning capabilities within the class and laboratories through individual departments after admitting them to the program concerned. The slow learners are guided by the teachers with extra classes and tutorials. The advanced learners are encouraged to participate in competitive exams, seminars, quiz, project work etc. They are also provided with reference books.

The main teaching-learning methods adopted by the faculty are lectures, experimental exercises, interactive sessions and role plays. The college needs to initiate more steps for developing problem solving technologies for enhancing teaching-learning processes. Also more initiatives need to be taken on group learning, project work, assignments, seminars, and subject related tours. Enhanced focus is required for communication in English.

The college has developed adequate ICT infrastructure in the form of IT enabled classrooms, Microsoft teams, Google meet and Zoom platforms for online classes and smart boards for effective teaching- leaning process.

It follows the affiliating university norms for the conduct of CIF. The college implements both summative and formative ways of evaluation at college level. 10% of the marks secured in internal exams at UG level and 20% at the PG level are added in final score of the student. The CIE is conducted through unit tests, home

assignments and quiz tests etc.

The performance of the students in the internal evaluation is discussed in the class. Transparency is maintained during the evaluation process as answer sheets are shown to the students by the teachers for any clarification.

The college examination committee deals with examination related grievances/ mal-practices. Students grievances related to the university exams, mark sheets, re-evaluation etc. is forwarded to the university through proper channel for appropriate action.

The Program Outcomes (POs) and Course Outcomes (COs) for all programs are stated and displayed on the college website and communicated to the students and teachers. However, proper mechanism to evaluate the attainment of these out comes need to be strengthened.

Qualitative analysis of Criterion 3

The college needs to create an eco-system for innovations including incubation center and other initiatives for creation and transfer of knowledge.

The major extension activities of the college are done through NSS, NCC and Red ribbon Club. Visits to Orphanage and Old age Homes are considered best practice which sensitizes the students to human values as well as other social issues as confronted by orphan children and senior citizens. The other activities undertaken by the college include blood donation by students and staff, aids awareness program, Swachh Bharat Abhiyan. Programs are also organized to show cause the rich Chhattisgarh culture. The institution has organized 58 extension and outreach programs and has won 16 (NSS - 2, NCC - 9, Sports - 5) awards during the last five Ashnahl - wards years.

More efforts need to be put in by the college to strengthen and improve research work and promote a better research culture. Monitory and non-monitory awards need to be provided to the teachers who receive state, national and international recognition and awards. Faculty should be encouraged to act as Research Guide and also prepare and submit proposals to various research agencies like UGC, ICSSR, ICSR and dept. of Science and Technology. Industry sponsored projects is another area to be explored. More National and International level Seminars/Webinars/Workshops/Conferences ought to be conducted and attended by students and faculty.

Qualitative analysis of Criterion 4

The college possesses adequate physical infrastructure in the form of classrooms, laboratories, library, computer and IT laboratories, sport and gym facilities, open auditorium, cycle stand, girl's common room, canteen and yoga center to cater to the academic, co-curricular and extra- curricular needs of UG and PG students. It is housed in 10.61 acres of land area. There are 13 classrooms (some of them fitted with overhead projectors), 78 computers, 01 girl's common room with toilet facility and sanitary wending machine and incinator (destroying) machine. The college needs to establish more smart rooms fitted with upgraded ICT equipment. English language lab requires up-gradation.

The college has outdoor sport facilities such as Kho-Kho, Netball, Handball, Kabaddi, Handball etc. It has open auditorium for rehearsal and conduct of cultural activities. The college needs to develop more indoor sport facilities. College library has 23125 text books, 353 reference books and magazines and is partially automated with ILMS 2.0 software. It requires to procure rare books, manuscript, special reports, e-books and research journals and other knowledge resources for its enrichment.

The college provides ICT facilities in the form of OHP/LCD projectors, smart/interactive boards to its teaching departments and library. The whole campus is WI-FI enabled with lease-line of 50 MBPS. The ICT

facilities are periodically upgraded with latest hardware and software as per requirements as it facilitates online learning through plate forms like Google Meet, Microsoft, Zoom etc. It needs to add more computers to enrich the existing IT labs for effective teaching- learning.

The physical facilities including classrooms, laboratories and computers are made available for utilization by the students. The maintenance of physical facilities is done through State Public Works Dept., hiring of external agencies on demand and with the efforts of its own staff. All sports equipment and playfields are maintained by the sports director and his staff.

Qualitative analysis of Criterion 5

Good number of students has availed the benefits of scholarships and free ships provided by the institution, Govt. and non- Govt. bodies, Industries, individuals and philanthropists.

There is an active Student Representative Council formed as per affiliating University and State Govt. norms. The members of the council are placed on the statutory and non- statutory committees like anti- ragging committee, women cell and committee for prevention of sexual harassment, NSS, NCC, Cultural, Sports, Janbhagidari committees and Amrit Mohotsav. The presence of council members is ensured in organization of activities/ events like celebration of Republic/ Independence days, annual day, debate, quiz, seminars, rangoli, flower and mehndi competitions etc. Their involvement helped the college administration in maintaining discipline within the campus besides smooth conduct of curricular and co-curricular activities. Students have won awards/medals for outstanding performance in sports/cultural competitions at Inter-University/State/ National levels. 26 students have qualified the State/ National competitive exams during the last 5 years.

The alumni association of the college was registered on 23.03.2021, functional. It is working through elected executive council. Contribution made by alumni in monetary and non-monetary shape is worth to be appreciated. More focus is required to guide the students for competitive exams, placement and entrepreneurship. Data base for placement and progression to higher education needs to be strengthened.

Qualitative analysis of Criterion 6

It is being a Govt. College controlled and administered by Higher Education Dept., Chhattisgarh Govt. The vision and mission of the college focuses on quality and value based higher education to students with holistic development. It also provides a platform for academic intelligence, creativity and physically energizes them through sports. It has a defined organization structure. It practices decentralization and participative management through various college committees comprising HODs, faculty (teaching &non-teaching) and students. The college has well executed administrative, academic and financial plans. The functioning of the institution is effective as reflected from policies framed, administrative setup, appointments and service rules and procedures etc.

Since it is a Govt. college teaching and non- teaching staff enjoy all the welfare measures like casual leave, earned leave, study leave, maternity leave, paternity leave, child care leave, gratuity, leave encashment etc. as applicable to all other state govt. employees and pension, after mortality benifit of Rs- 50,000/- etc. There is also a provision for grant of leave for attending Orientation/Refresher course/ Faculty development programs.

Internal audit is done by the committee of faculty so constituted. External audit is done at two levels: one by Audit team of Directorate of Hr. Education and second by Office of Accountant General, Chhattisgarh.

The major sources of funds are fees from students, State govt. and RUSA. The college needs to mobilize funds from offering of self-financing/ job oriented courses, UGC, Research projects and consultancy, alumni and private donors. It also needs to ensure their optimal utilization.

IQAC has initiated few strategies and processes in the college post 2nd cycle re-accreditation by the NAAC. Besides starting of two PG courses i. e. M.Com and M. A. Political Science, it acts as torch bearer in initiating and organizing curricular, co-curricular and extra-curricular activities in the campus. Special facilities for specially- abled students have been created. Another area of contribution of IQAC is the use of ICT in teaching processes. It needs to put more efforts for institutionalizing the quality assurance strategies and processes. IQAC being the central body within the college, it monitors and reviews the teaching-learning methodologies regularly. To enhance the professional development of faculty, it has organized seminars, workshops. Start of add-on-courses on life science, development of faculty, it has organized seminars, research projects, institute-industry interface, computerization of academic processes, up-gradation of physical facilities through college funds and RUSA grants are few more initiatives initiated by IQAC.

Qualitative analysis of Criterion 7

Having about 75% girl students on roll, the college is sensitive to the security needs of women. It has installed 24x7 CCTV surveillance system within the campus. The institution has various measures in place to ensure the safety and security of students like deployment of security guard for monitoring and guarding the campus, girls common room fitted with sanitary napkin wending machine and incinator presence of women cell/ prevention of sexual harassment cell/ anti ragging cell, installation of drop boxes at prominent places for receiving grievances, conduct of special counseling and guidance sessions. It also organized program on Beti Bachao, Beti Padhao, lectures on domestic violence, women rights and women empowerment, free medical/ health check-ups. It has started job oriented course on Beauty Parlor. Besides, girl students are encouraged to take active part in academic, co-curricular and extra- curricular activities.

Some arrangements have been made for disposal of solid, liquid and bio-medical waste. Dust bins have been placed at prominent places for collection and disposal of waste. Old stuffs of sports/newspapers etc. are disposed for recycle and reuse. Used water from taps and bore well are directed towards garden and waste from toilets is connected to main drainage. The college needs to develop scientific mechanism for disposal of bio-medical, e-waste and waste recycling system.

The NSS, NCC, cultural committee and teaching departments make effort in developing inclusive environment. It organizes various programs/events to celebrate cultural and regional festivals like New Year day, Basant Panchami, Christmas, Diwali, Sankranti etc. It also celebrates Unity day, National Integration day, Sadbawana divas. As symbol of tolerance and harmony, blood donation camps are organized, visit to old age home and orphanage and Anganwadi is arranged.

The college organizes programs to sensitize the staff and students towards constitutional obligations, rights, duties and responsibilities. These include environment awareness, protection and care for animals, health awareness, corona awareness etc. It also organizes events on Hindi divas, NCC and NSS days, Human right day, constitution day, Sanskrit day, Yoga day SVEEP etc.

The college does efforts for Green Audit, Gender Audit, Energy Audit and Environment Audit, Academic Audit, LSRW Audit by English Department, etc.

The college celebrates state/national festivals like Independence and Republic days, Constitution day and Chhattisgarh day. It also observes birth/death anniversaries of great Indian personalities like Mahatma Gandhi, Swami Vivekananda, Sardar Vallabhbhai Patel etc.

Institutional best practices are: (a) Nurturing the social ethics of love and care for the orphans and the Senior Citizens; (b) preserving, securing and nurturing love and admiration for Chhattisgarh culture.

The distinctiveness of the college is the enrolment of large number of girl students (75%) especially from the socially deprived strata studying in conducive environment that offers ample opportunity for their holistic development.

Strength:

The college is 2nd cycle NAAC re-accredited with 'B+' Grade. It has a spacious campus of more than 10 acres. It has been providing higher education to the needy and first generation learners in the vicinity and beyond. It offers 36 UG and 05 PG programs. Qualified and dedicated faculty, 10 of them designated as

research guides. The college is committed to social service through extension activities. It has safe and secure campus with CCTV surveillance and security guard. It maintains good relationship between students and teachers.

Weaknesses:


Fees from students and funds from State govt. is the only source of income. It offers education to socially and financially deprived students. Students have weak communication skill in English. It has inadequate research facilities. The college has very less number of add-on/job-oriented/ professional courses. Limited library facility is another weakness. Campus placement and Industry collaborations are negligible.

Opportunities:

The college has spacious campus with scope to develop good sport facilities. As girl students constitute about 75% of the total enrolment, there is an opportunity to start more skill oriented courses like flower arrangement, mehndi designing, beautician, fashion designing etc. The college being located near the industrial area, there is an opportunity to explore industry sponsored projects. There is scope for more consultancy and greater interaction with institutions near and outside the region. Choice based credit system could be initiated by the university in the college.

Challenges:

Big challenge of the college is to transform slow learners to advance learners. To increase attendance is another challenge faced by the college as large number of students do part-time jobs to meet their economic needs. Another challenge is to motivate the students to speak English. The college administration and faculty faces the challenge of improving the academic result as well as mobilizing funds from research projects. Placement cell needs to be strengthened.
